

NOTICE OF FORECLOSURE SALE

ASSERT AND PROTECT YOUR RIGHTS AS A MEMBER OF THE ARMED FORCES OF THE UNITED STATES. 2. *Instrument to be Foreclosed.* The instrument to be foreclosed is the Deed of Trust dated 05/24/2008 and recorded in Book 1735 Page 393 Document 2009882 real property records of Brown County, Texas.

4. *Terms of Sale.* The sale will be conducted as a public auction to the highest bidder for cash. 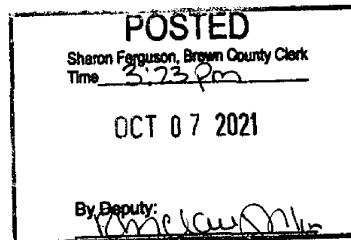
