

DRIVING SAFETY COURSES - [AVAILABLE TO NON-CDL-TEXAS LICENSEES OR ACTIVE MILITARY ID ONLY] ---You may be able to request that this charge be dismissed by successfully completing a driving safety course or a motorcycle operator training course. You will lose that right if, on or before your appearance date, you do not provide the court with notice of your request to take the Course. You do not qualify for defensive driving if you were cited for speeding 25 mph or more over the speed limit. If you do not successfully complete your course and meet all statutory requirements within the time given after approval by the court, you will be required to pay additional costs.

ON OR BEFORE YOUR APPEARANCE DATE YOU MUST FURNISH THIS COURT IN PERSON OR BY CERTIFIED MAIL RETURN RECEIPT REQUESTED:

1. Your copy of the citation.
2. A Court and Administrative Cost of \$130.00. NO PERSONAL/COMPANY CHECKS.
3. A signed and notarized Affidavit on the form furnished below.
4. Proof that you were covered by liability insurance at the time you were ticketed. This may be satisfied by (a) a liability insurance policy (or photocopy) covering the vehicle that you were driving, (b) an insurance card issued by an insurance company stating that you were properly insured while driving the vehicle in which you were stopped or (c) an insurance binder showing that you were insured at the time of your offense.

WITHIN (90) DAYS AFTER COURT APPROVAL YOU MUST FURNISH THIS COURT:

1. The Court copy of a Driving Safety Course or Motorcycle Operator Training Course Certificate of Completion issued by an approved school and taken AFTER approval by the court, and
2. A certified copy of your driving record dated after the date of your offense showing that you have not successfully completed a Driving Safety Course or Motorcycle Operator Training Course under the below-referenced subsection within the last year before the date of your offense. We will provide you with the form to obtain your driving record or you may order it online at [www.texasonline.com](http://www.texasonline.com).

### **PLEA, REQUEST AND AFFIDAVIT**

I hereby enter a plea of **NOLO CONTENDERE** to the offense charged, waive a jury trial, ask the Court to grant me time to take a Driving Safety Course or Motorcycle Operator Training Course, and declare that I am not indigent. I have a valid Texas Driver's License, Permit No. or Active Military ID #\_\_\_\_\_. I am not currently taking a Driving Safety Course or Motorcycle Operator Training Course under Section 45.0511 Texas Code of Criminal Procedure, nor have I completed a course under this subsection that is not yet reflected on my driving record (for the purpose of dismissal of an offense other than the one to which I am now pleading).
